Excluded: Managerial executives, confidential employees, and supervisors within the meaning of the Act; craft employees, police, casual employees; Director, Assistant Director, Manager–Adult/Technical Services, Manager–Youth Services, Manager–Information Services, Manager–Information Technology, Manager–Circulation Services, Supervisor-Passport Services, Supervisor-Building Maintenance, Executive Administrative Assistant, Accounting Clerk, Library Assistant 3; and all other employees of the East Brunswick Public Library.
